Listen to the community

My vote in the last election specifically excluded the councillors I thought were driving this football-club centric, exorbitant project that lacks both robust financial planning and sensitivity to the community's needs. It is eroding the towns other sporting clubs and completely ignoring the needs of more than half the town's sporting community. It is also making non-sporting rates payers (the artists, the business owners, the retirees) fund debt associated with one specific club that isn't even tangential beneficial to them. This project seems to be driven by certain male egos, and it is disappointing that thus far our Shire President is not providing stronger leadership and challenge to those egos. Is she and the rest of council being led by the Shire CEO? Or is the bullying of male DFC "big shots" to push this through getting to them?

This is exactly the sort of strategic decision where councillors should represent the members of the community, the majority of the community, not blindly follow the recommendations of a CEO...his role is administrative. The CEO should be instructed and led by the councillors, not vice versa. The councillors are dividing the town into 2 opposing camps - DFC supporters and everyone else (the silent majority) - by throwing so much money (and debt) at what will effectively become DFC's Club Rooms (the request for DFC's financial investment is a strong indicator of that).

As for any proposal for naming it the "Chris Sheehan" Pavilion, this is again incredibly insensitive. Being a recently deceased football player and popular "blokes-bloke" shouldn't warrant such expensive, tax-funded idolatry. How is Chris Sheehan more iconic of the town's sporting community than its quiet, hard-working volunteers (past and present) in netball, soccer, hockey, swimming, tennis or any other sport? I'd rather see it called the Maureen McCabe or Jeanette Atherton Pavilion, or any other dedicated volunteer and sportsperson who has worked with kids and sports development for 30+ years without financial involvement. It would be nice to have a DBK sports facility named after a female community member for a change, they are after all 1/2 the community and more than 1/2 of the volunteers.

And just to be clear, like many others, I don't Facebook about my concerns...with a family, work and a business, I'm too busy and it's a small town where my family and I live.

Nor am I a member of the Ratepayers Association. However at times like this where Council seems to be so blatantly ignoring the wider community in favour of DFC lobbyists, I think the Ratepayer

Association's role is important. I'm glad that they are taking the time to raise these issues and at least attempt to keep Council accountable. I know several of the councillors personally and I'm sure they haven't intended to become so disconnected from the majority of the community that voted for them, but sadly they have.

Please stop listening to big egos like the CEO and the Footy Club lobbyists and listen to your wider community. It's not too late and you'll be widely applauded, I suspect more widely than the councillors realise.

On another note...Thankyou. I appreciate the enormous, selfless and, often, thankless commitment it takes to be a Councillor. Personally I wouldn't be brave enough. While I don't respect the current version of the project proposal or the drivers behind it, I do respect your service to your community. Please remember, the CEO is supposed to be a paid administrator in your service who must respond to you as Council. The majority of the community opposes this project, as evidenced by the recent shire election results.

The Anna Dixon report raised serious concerns over the plan and strongly suggested it would not be viable.

In the high likelihood that this development is a costly failure, all Councillors who voted for it should be held liable.

The only feasibility study (Anna Dixon) released, the Stakeholder Group, the majority of the community have all made it very clear this project is not viable in it's current form.

Councillors who voted for this have defied logic, public opinion and expert evidence. That is negligence of duty.
